Directions

The purchaser of the service, hereinafter referred to as "Purchaser," desires to hire DJ Express, hereinafter referred to as "Artist," to provide DJ services as described in the following notes:

The Purchaser and Artist hereby mutually agree to the following terms:

1. The Artist agrees to provide the Purchaser with the DJ services as decided above and at the above designated location, date, and times.
2. The Purchaser, in consideration for these services, agrees to pay to the Artist the deposit with the return of a signed copy of this agreement and furthermore agrees to pay the balance due to the Artist prior to performance of the event. Final payment must be paid 7 days prior to the event date, in the form of cashier's check/Money order made payable to Lesmen's Music.
3. The Purchaser agrees that as a condition precedent to the performance of the terms of this agreement with the Artist, he/she will have, prior to the time of the engagement, secured the facilities for the engagement as well as any and all stamps, licenses, authorization and permits that are necessary and proper to allow the Artist to execute the terms of the agreement.
4. Liability of the Artist shall not exceed the total cost of the DJ services provided herein.
5. The Purchaser agrees to the following cancellation policy:
 - A. If the DJ services as stipulated in this contract are canceled by Purchaser more than 30 days from the date of the performance, Purchaser will be refunded 1/2 of the deposit.
 - B. If the DJ services as stipulated in this contract are canceled less than 30 days from the date of the performance, Purchaser forfeits the entire deposit.
6. The Artist has the option of not providing the services described above if final payment is not received by the Artist prior to the beginning of the performance
7. Any time change will incur a \$100.00 charge. (Only if Available at that time).

Payment - Last minute add-ons must be paid before show no matter the urgency. A credit card number on file is very helpful in these situations.

Electrical Requirements: 30 amp electric service If a generator is to be used, it must be approved by Lesmen's Music.

Any damage caused by a generator is the responsibility of the customer and/or the generator provider.

Access - All staging must be in place at load-in time. Direct access to the stage by the Lesmen's truck must be provided for load-in and load out. All other situations must be negotiated, as they require extra crew to be present. Storage space for empty equipment cases must be provided on-site.

Parking for the Lesmen's Vehicles' This includes any passes and permits required by any controlling entity.

Security - Reasonable security must be provided for Lesmen's equipment that is setup prior to event.

Outdoor Venue - Lesmen's requires that a tent or canopy cover the entire system and lighting. Lesmen's reserves the right to Terminate the event if Rain, Hail, Wind, Snow or associated bad weather may cause damage to equipment (No refunds apply).
